Why do I need a neck cream. Can't I use my face moisturizer? You need a neck cream because the neck ages differently than the skin on your face and requires its own unique, topical anti-aging technology. Facial moisturizers will only provide minimal benefits and anti-aging results to the neck.

2 What are some of the most common signs of aging on the neck? The most common signs of aging on the neck include: slackened skin, crepiness, horizontal necklace lines, turkey neck appearance, platysmal bands, fat accumulation and mottled skin appearance.

3 How does Nectifirm® address the signs of the aging neck? Nectifirm® contains a blend of five peptides which strengthen the dermal-epidermal junction (DEJ) for firming and lifting the skin on the neck. Several potent extracts lessen the look of fine lines and wrinkles and smooth away crepiness. A unique blend of Bamboo, English Pea Extract and Glucosamine helps reduce the appearance of wrinkles.

4 What is the dermal-epidermal junction (DEJ)? The dermal-epidermal junction is a specific area of skin where the dermis meets the epidermis. During youth this junction is very "wavy". With age, this junction flattens and skin becomes more slackened. It's a key area for skin cell communication and cohesion. Research has shown that addressing the health of the DEJ greatly affects the outward appearance of the skin.

5 Which ingredients help reduce fat accumulation in the neck? Dihydromyricetin, a derivative of the Wax Myrtle Shrub, and Methylsilanol Carboxymethyl Theophylline Alginate reduce the appearance of adipose tissue in the neck.
